The Silver Ball in 2023 Marked 25 Years of Support

The Glen Ellyn Library Foundation celebrated its 25th Anniversary in 2023, and reflected on a quarter-century of meaningful impact and dedicated service to the Library. The Foundation kicked off its silver anniversary by hosting The Silver Ball on April 28, 2023 at The Morton Arboretum. The Foundation raised an impressive \$270,000 to grow the Foundation's endowment as well as help fund the Library's new makerspace, a place where people can learn, create, and collaborate while using shared resources and technology. The Glen Ellyn community came together to support The Silver Ball with the following:

- 210 guests
- 250 raffle ticket purchases
- 57 live and silent auction purchases
- 90 live and silent auction donors
- 34 individual and corporate sponsors
- 40 committee chairs and volunteers
